### Other important information

- Please note that other documents may be required.
- The original of each required document must be accompanied by a photocopy, which will remain in the file.

### Processing time

- The visa application can be submitted 6 months and at the latest 15 days before the planned date of departure for Switzerland.
- The processing time is between 5 and 7 working days, or more depending on the particular case.

### Visa fee\*: exact amount to be paid in cash and in FCFA at the counter when submitting the application

- Adults and children over 12: XAF 60,500 / children between 6 and 11: XAF 30,500 / children under 6: free

### Free visa for

- Spouse / partner / child under 21 years of age or permanently dependent\*\* / child of spouse/partner / permanently dependent ascendants\*\* /ascendants of the spouse/partner of an EU, Swiss or EFTA national whose family relationship is proven by a civil status document (marriage certificate registered at the civil status office of the Schengen State national, etc)

- Applicants on official travel

\* Prices may change without notice

\*\* proof of regular support (payments, money transfers, etc.) must be attached to the file. Taking care of the person during his or her stay in Switzerland cannot be considered as permanent support.
