

Leaflet SWISS SCHENGEN VISA TOURISM

General application rules:

- Only visa applications with Switzerland as a main travel destination are accepted.
 In case of multiple destinations, the visa must be submitted at the Embassy of the country where the <u>longest stay</u> will be.
- All requested documents <u>have to be translated</u> into German, French, Italian or English
 A list of recognized translators can be found at the Embassy website:
 https://www.eda.admin.ch/countries/egypt/en/home/dienstleistungen/arzt-anwalt.html
- If a requested document cannot be provided, there must be a written explanation instead, clarifying why the document is not available.
- The visa fee will not be refunded in case of refusal or withdrawal.
- Communication regarding visa matters is only accepted in written form to <u>info.cheg@vfsglobal.com</u> or by calling <u>+20221600058</u>
- The mandatory "Schengen Consultation", which takes a processing time of at least 10 working days, can only be started upon receiving a complete application file meeting the requirements.
- The Embassy reserves the right to ask for additional documents or a personal interview with the
 applicant.
- During the visa processing time, no passport withdrawal is possible.

How to apply:

Prior to the submission of a visa request, an appointment has to be fixed with our external service provider <u>VFS Centre</u> only online on the VFS website: https://visa.vfsglobal.com/egy/en/che/

Insurance	valid for all Schengen countries
	> minimum coverage must be EUR 30'000.00 (this includes expenses of
	repatriation for medical reasons, urgency medical attention, emergency hospita treatment or death during the stay)
	 a printout certificate/policy in English of *AMAN sticker* on the passport.
Visa Fees	> payable in EGP (only exact amount is accepted!)

Additional special requirements			
For foreigners living in Egypt	>	must have a residence permit in Egypt valid for at least 3 months beyond the return from the planned trip	
For minors	>	if the minor travels without parents or legal guardian: consent of parental authority or legal guardian provided either through a notarized certificate or by a letter signed at the Embassy or VFS office	
	>	if the minor travels with one parent or legal guardian: consent of parental authority or legal guardian, who is not travelling with the child, provided either through a notarized certificate or by a letter signed at the Embassy or VFS office	
	>	passport copy of both parents or legal guardian (only biometric data page + page with the signature)	
	>	Translated Birth Certificate of the minor.
