

Leaflet SWISS SCHENGEN VISA VISITING FAMILY / FRIENDS

General application rules:

- Only visa applications with Switzerland as a main travel destination are accepted. In case of multiple destinations, the visa must be submitted at the Embassy of the country where the <u>longest</u> <u>stay</u> will be
- All requested documents <u>have to be translated</u> into German, French, Italian or English *A list of recognized translators can be found at the Embassy website:* <u>https://www.eda.admin.ch/countries/egypt/en/home/dienstleistungen/arzt-anwalt.html</u>
- If a requested document cannot be provided, there must be a written explanation instead, clarifying why the document is not available
- The visa fee will not be refunded in case of refusal or withdrawal.
- Communication regarding visa matters are only accepted in written form to <u>info.cheg@vfsglobal.com</u> or by calling <u>+20221600058</u>
- The mandatory "Schengen Consultation", which takes a processing time period of at least 10 working days, can only be started upon receiving a complete application file meeting the requirements
- The Embassy reserves the right to ask for additional documents or a personal interview with the applicant
- During the visa processing time, no passport withdrawal is possible.

How to apply:

Prior to the submission of a visa request, an appointment has to be fixed with our external service provider <u>VFS</u> <u>Centre</u> only online on the VFS website: <u>https://visa.vfsglobal.com/egy/en/che/</u>

International Travel Insurance	 covering the entire period of intended stay valid for all Schengen countries minimum coverage must be EUR 30'000.00 a printout certificate/policy in English of *AMAN sticker* on the passport.
Original bank statement	 covering the past six months only current or saving accounts (Deposit Certificates will not be considered!) closing balance must show sufficient means to cover the expenses of the trip
Visa fees	payable in EGP (only exact amount is accepted!)
