Chers compatriotes du Ghana, du Togo et du Bénin, Chers amis de la Suisse,

"The Times They Are a-Changing" - Cette célèbre chanson de Bob Dylan me vient à l'esprit lorsque je me remémore l'époque de janvier 2020. Quelques semaines avant l'apparition de la pandémie de COVID-19, l'ambassade était très occupée et excitée, par les préparatifs de la visite d'Etat historique du Président ghanéen en Suisse. Coronavirus (COVID-19)

Travelling to Switzerland during Covid-Pandemic:

Since 22 January 2022, persons who have been vaccinated or have recovered from Covid-19 will no longer be required to present a negative PCR or rapid antigen test before entering Switzerland. A valid vaccination certificate has to be shown. If you hold a foreign certificate, you may be eligible to ask for a Swiss Covid certificate for your travel to Switzerland. For further information how to obtain the Swiss Covid certificate, please consult the webpage of FOPH/certificate.

Persons who are not vaccinated or have not recovered from Covid-19 will still have to take the PCR- or antigen test with negative result to enter the country and may only travel with proof of a hardship situation.

COVID-19: Information for Swiss nationals about vaccine

Swiss nationals residing abroad must comply with the vaccination requirements of their host country. For logistical reasons, the vaccines administered in Switzerland cannot be dispatched to the external network. No vaccine deliveries are planned by the Federal Department of Foreign Affairs for Swiss nationals living abroad.

Persons insured under the Swiss compulsory health insurance (basic insurance) with a Swiss provider have the possibility to be vaccinated in Switzerland. Please, contact your health insurance provider and/or your Swiss general practitioner (médecin de famille/Hausarzt).

Swiss nationals abroad not covered by a Swiss health insurance policy should contact their health insurance provider to find out about the vaccination policy in their host country.

Processing of Visa applications

Since July 2, 2021 Visa type C (stay up to 90 days) for fully vaccinated, recovered from Covid–19 or hardship applications are processed through VFS Global. Contact VFS Global directly for appointments to submit a visa application.

Long-term "D" visas (student, family reunion or any other stay over 90 days) must be submitted to the Embassy by appointment only. Any requests should be sent by email to accra.visa@eda.admin.ch

A Schengen Visa issued by Switzerland does not guarantee entry permission to other Schengen States. Covid-19 regulations and entry requirements vary for each Schengen State. Even if you do not need a visa to travel within the Schengen Area, it is mandatory to verify conditions for each country you might visit before leaving the home country.

Since November 1st 2021, the Swiss Embassy in Accra resumed processing short stay visas (stays up to 90 days/Visa type C only) for travel to Belgium and Latvia. Visa applications are processed through VFS Global.

Politics & Bilateral Relations

Bilateral Relations

On 8 December 2021, the Federal Assembly elected Federal Councillor and Foreign Minister Ignazio Cassis as President of the Swiss Confederation for 2022.

Addressing the Federal Assembly, President-elect Cassis focused on the Covid Pandemic, noting: "With the strength of our pluralism and our innovative spirit, we can overcome this challenge together". He also underlined Switzerland's role abroad: "In my dual role as President of the Swiss Confederation and head of the FDFA, I will invite our foreign partners — within the limits dictated by the pandemic — to join me in Switzerland, where our citizens help to shape our foreign policy objectives".

Earlier in November 2021, a delegation led by the Head of Africa and the Francophonie Division of the Swiss Federal Department of Foreign Affairs, Ambassador Siri Walt, was in Ghana for the Sixth Round of Political Consultations between both countries.

Topics were of mutual interest and spanned Ghana-Switzerland Economic Relations, Economic Development Cooperation, Cooperation under Article 6 of the Paris Agreement; Cooperation in the field of Cocoa sector and other industries as well as aspects of Digitalization and Cooperation in Human Rights among others. Switzerland is happy to host the next round of talks in Berne in 2022.

A the end of October, a delegation from the Swiss Armed Forces led by Brig. Gen. Markus Mäder paid a courtesy visit to the Minister of Defence Hon. Dominic Nitiwul. The delegation from Berne travelled to Ghana to visit the Kofi Annan International Peacekeeping Training Center (KAIPTC) with the aim to deepen relations between Switzerland and the leadership of KAIPTC. Brig. Gen. Markus Mäder also engaged with participants at the closing ceremony of the Swiss-funded annual Protection of Civilians Course.

The year 2021 marked 15 years of Swiss presence and cooperation at the Centre and the visit offered a great opportunity to take stock of Swiss support over the years. ■

High level contacts & missions from Switzerland

Back in August, the Embassy received a mission from the Peace and Human Rights Division of the Federal Department of Foreign Affairs. Ambassador Stalder introduced the Swiss experts to the Ministry of National Security and hosted a cocktail at his Residence in the presence of Hon. Minister Albert Kan-Dapaah. The event brought together diverse stakeholders in the area of Prevention of Violent Extremism.

Switzerland fights corruption globally and welcomes the establishment of effective and independent anticorruption agencies. Corruption is a tremendous barrier to sustainable development. In this perspective, Amb. Stalder met with Mr Kissi Agyebeng, Office of the Special Prosecutor - Ghana, to speak about the operationalization of the OSP since his appointment in July 2021.

The Ambassador visited Mme. Elizabeth Naa Kwatsoe Tawiah Sackey, the Chief Executive of the Accra Metropolitan Assembly (AMA) to discuss Switzerland's support for the Ghana Urban Mobility and Accessibility Project (GUMAP) - with a grant of USD 6 million from the Swiss government to strengthen the capacities of selected areas in the Greater Accra Municipality in public transport planning and traffic management.

Since the outbreak of the pandemic, Switzerland works for global solutions for an equitable distribution of COVID-19 vaccines and is proud to support the Covax initiative which aims to fairly distribute vaccines. To highlight our engagement and to get a first-hand briefing about Ghana's respective policies, Amb. Stalder met the Minister of Health, Hon. Kweku Agyeman-Manu. The activities of Swiss pharmaceutical companies in contributing to Ghana's health sector were also discussed.

Switzerland welcomes Ghana's efforts better ensure sustainable management and utilization of the country's lands, forests and wildlife resources as well as the efficient management of mineral resources for growth & development. In a meeting with Hon. Samuel Abu Jinapor, the Swiss envoy also mentioned the opportunities which the new bilateral agreement on climate change under article 6 of the Paris Accord could hopefully bring for both our countries. During the cordial exchange, problematic aspects of "galamsey" (illegal small-scale gold mining) for Ghana's habitat were equally raised and discussed.

Development Cooperation

Financial Programming

As part of the Macroeconomic Planning and Management Project (MPMP), the Embassy attended a workshop in Aburi with the Ministry of Finance's Economic Strategy & Research Division. Participants developed macroeconomic projections for Ghana's 2022 budget and provided insights on debt sustainability. Through the MPMP, Switzerland provides technical assistance to the Ministry of Finance, the Bank of Ghana, the Ghana Statistical Service and the National Development Planning Commission to develop a comprehensive financial programming model for budget preparation and to increase confidence in public finances.

Business Environment

One of the priority areas of the Swiss development cooperation in Ghana is the improvement of the business environment. Through the Multi Country Investment Climate Program, which is implemented by the International Finance Cooperation (IFC), two important contributions were made recently: the new Company's Act 2019 is an important milestone on business registration and regulation in Ghana. In order to implement the act, the program supported the Government of Ghana to draft regulations, which finally give effect to the Act. The program facilitate consultations with different stakeholder in order to take their comments and concerns on board. The second important contribution to a better business environment in Ghana was the drafting and consequently the dissemination of a user guide on the Corporate Insolvency and Restructuring Act. It will make sure that things are going a proper course also when companies are not doing very well.

Business Improvement

In November 2021, the Swiss Embassy paid a visit to some of the enterprises that received training and coaching under the ILO SCORE program. Feedback received from stakeholders underlines the value of progressive improvement to businesses and this validates the efforts of Switzerland to promote more and better jobs in Ghana. The Sustaining Competitive and Responsible Enterprises (SCORE) program provides on-the-job training for workers and managers to attain increased productivity, cost reduction, improved delivery time, better working conditions, less waste, less defects and safer working environment for SMEs and this helps them to participate in global supply chains. The program has been co-funded by SECO since 2011 and completed its third and final phase in December 2021. While celebrating the achievements, the mandate of the post-project SCORE training was officially handed over to a local organization MDPI Ghana at the last steering committee meeting.

Swiss Platform for Sustainable Cocoa

In November, the Deputy Head of Cooperation, Mrs. Anne Schick and the visiting Executive Director of the Swiss Platform for Sustainable Cocoa, Mr. Christian Robin, held fruitful discussions with the CEO of COCOBOD Mr. Joseph Boahen Aidoo on joint ways forward in the cocoa sector. The Swiss Platform is a multistakeholder initiative for more sustainability in the cocoa value chain bringing together all stakeholders together by actively improving the living conditions of cocoa farmers.

Foreigners Identification Card



Have you registered for your Foreigners Identification Card? You should, if you are:

- a foreign national permanently resident in the country
- a foreign national who is cumulatively resident in the country for at least ninety (90) days in any calendar year.
- All foreigners six years +

Itineris - Plan well, travel well.



The Embassy of Switzerland in Ghana strongly recommends its fellow citizens to register with Litineris, which allows entering dates of your leisure or business trips. It helps the Federal Department of Foreign Affairs to locate and contact you more rapidly if a serious crisis occurs abroad and to warn you if the security situation in a region suddenly deteriorates drastically.

Please install the app on your Smartphone free of charge.

Keep your data updated



Regular contact between yourself and our Embassy can be very useful to both parties. To ensure that you can be contacted quickly, it is important that your contact information (address, phone number and email) is always up to date.

Reporting a change of address will also enable you to continuously receive the documentation on your right to vote by correspondence (if you are registered in the electoral roll), as well as the "Swiss Review" published by the Organization of the Swiss Abroad (OSA). This magazine is distributed free of charge to Swiss citizens registered abroad.

At the same time, according to the Ordinance on Civil Status (OCS), it is your obligation to report any changes in your civil status to this Embassy. Therefore, kindly inform us about any changes in your civil status: marriage, birth of a child, divorce or death of a relative, by e-mail or through a personal visit at the Embassy (with a prior appointment via email) from Monday to Friday between 8-11 AM. We will be happy to advise you on the required documents.

Automation of the life verification process for certain OASI/DI pension beneficiaries

As of 2022, a new life verification process will come into effect thanks to the implementation of automated exchanges with various partner administrations of the Central Compensation Office. The insured persons concerned by these exchanges will no longer receive the «Life status» form to be certified.

The SCO and OAIE will launch an information campaign for the attention of the insured persons concerned at the beginning of 2022, which will be staggered throughout the year. Each insured person will thus be informed personally at the time when they should have received the form.
