

Terms & Conditions of the photo entry #SwissFilmsonWheels on the Facebook page of the Embassy of Switzerland to India and Bhutan

RULES OF CONTEST

1. You may submit one photo on the following subjects:

One selfie photo from a “Swiss Films on Wheels” film screening of the Swiss films “Heidi” and “My Life as a Zucchini” showing yourself with one of the cutout figures of the two films. Six cutout figures are available near the screen during the film events. Each of the six figures can be chosen for the selfie.

2. Each submission must be accompanied by details on the photographer, the date and location the photo has been taken as well as a relevant caption.

3. The photo submission must be created and owned by the participant.

5. Photographs may be submitted starting on March 6th 2018. You send the photo to ndh.events@eda.admin.ch. Don't post it on the Embassy's Facebook page. The last deadline for photo submissions is 31st May 2018. You may post it on your own Facebook page.

6. Photographs must be submitted in a digital format. We recommend submitting a high resolution image.

7. All submitted and accepted images will be screened by entry date by an Embassy committee. The entry date determines the selection of 10 photos each month, starting from March 2018, ending in May 2018, 30 photos in total. The senders of the 10 photos will be selected each month. There will be 30 winners in total: 10 winners in March 2018, 10 winners in April 2018, 10 winners in May 2018. Winners of a prize will be notified through mail until the end of each month (March 2018, April 2018, May 2018).

8. Participants can only win one prize. Per participant only one selfie photo can be submitted.

PLEASE NOTE: Decisions are final and not subject to negotiations or appeal.

PHOTO CONTEST PHOTOGRAPHY RIGHTS

1.1. By submitting works to this contest you confirm that for each work submitted;

a. You alone are the author of your work and that it is your original work,

b. You are the sole copyright holder,

c. You have not licensed any rights in the work to any third party,

d. It does not infringe on the copyrights, trademarks, moral rights, contract rights, or any intellectual property rights of any person or entity,

e. It does not violate the right to privacy and you have obtained, prior to submission of your work, any and all releases and consents necessary to permit the use of your work without compensation

f. You are not part of the staff of the Embassy of Switzerland to India and Bhutan.

You will be responsible for any claim made by any third party in respect of your entry and you agree to fully indemnify the Embassy of Switzerland in respect of all royalties, fees and any other liabilities owing to any person or entity by reason of your breaching any of the foregoing.

1.2. The Embassy of Switzerland reserves the right, in its sole discretion, to disqualify any entry that does not comply with any of the above.

2. Unacceptable Content

The Embassy of Switzerland reserves the right, in its sole discretion, to disqualify any entry:

1. That contains threatening, false, misleading, abusive, harassing, libelous, defamatory, vulgar, obscene, scandalous, inflammatory, pornographic or profane content,
2. That contains any material that could constitute or encourage conduct which would be considered a criminal offence, give rise to civil liability, or otherwise violate any law.

3. Your Copyright and Moral Rights of the author

The Embassy of Switzerland respects your rights and does not claim ownership or copyright for works you submit to this photo entry. You will retain full ownership and copyright.

In addition, your moral rights are respected. Whenever your photo is published you will be mentioned as the author of the image.

4. Use of Works

4.1. By entering this photo entry you agree that for any work that you submit the Embassy of Switzerland/FDFA will have the unlimited right to dispose of the work whenever, wherever and however it wishes. The right of disposal covers all current and future rights of use, copy, visual usage, publication and diffusion for promotional reasons during the submission procedure, for example on the Embassy's Facebook page
