

## **Checklist for Schengen Visa: Business**

Application should be submitted at the local Visa Facilitation Centre VFS. Switzerland Visa Application Centre website: <u>https://www.vfsglobal.ch/switzerland/india/index.html</u>

Please submit the documents in the exact order given below, please do not staple any document.		
Valid national passport :		
0	Issued within the last 10 years and with at least 3 months validity after the scheduled return, with at least two blank pages. Handwritten passports and passports with observations regarding the front page (bio data) cannot be accepted.	
1 passport size picture:		
0	White background, not older than 6 months (size 35 – 40 mm in width, not copied or scanned picture).	
0	Picture to be pasted on the application form, stapled or pinned pictures cannot be accepted. Visa application form :		
0	Completed and signed by the applicant, if applicable, authorization of third person.	
Introduction letter from the employer :		
0	Letter (original document), needs to be on a business letterhead from the employer/company.	
0	Letter needs to be signed and stamped by HR or directorate, mentioning person, position, duration of service, dates and purpose of the trip, plus stating, if expenses are covered by employer/company.	
Invitation letter from the business partner in Switzerland :		
0	Including full details of the inviter: full name, address, Email-ID and telephone number.	
0	Original or copy, signed & stamped, mentioning invitee details, dates and purpose of the trip, plus detailed schedule of the business meetings or training (day to day schedule).	
Trav	Travel Insurance :	
0	Please refer to the list of approved Indian travel insurances:

0	Minimum coverage of 30,000 Euro per person.	
0	Coverage of all expenses which might arise in connection with repatriation for medical reasons, urgent medical attention and/or emergency hospital treatment.	
0	The insurance has to cover the entire stay in the Schengen territory.	
0	Applicants who wish to apply for a six months or a one year multiple entry visa are not obliged to provide a 180 (365) day coverage. It is sufficient to submit an insurance policy covering the first journey.

0	With names of all travelers.	
Proof of financial status :		
	All documents have to be originals, in A4 format, with stamp and signature of Bank.

	Proof of employment: employment contract, last 3 months salary slips
