## List to establish Schengen privilege: instructions for external service providers/diplomatic missions

\* The applicant is responsible for providing proof to support claims for facilitation of a visa application as a family member. The applicant must prove that he or she falls under the definition of a family member, i.e. he or she must be able to produce evidence to support his or her application. The diplomatic mission remains responsible for verifying whether the applicant can be defined as a family member.
