



Visa application checklist



General Information

- You may submit your application up to six months before and no later than two weeks before your planned travel date. So applying early (8+ weeks) is crucial, factoring in time for appointment booking and passport return.
- Schengen visa processing takes about 15 calendar days but can extend to 30 days (or more) if extra checks are needed or during high seasons.

How to Apply for a Schengen Visa in two easy steps:

You have to apply for a Schengen Visa at the nearest designated visa application center, VFS Global in Astana or Almaty.

- 2) Prepare the necessary documentation for your visa application using the following checklists

Tourist visa

Please note, that the application has to be submitted to the Embassy/Consulate of the Schengen country that is your main destination according to the number of days you are spending there.

Only if you are spending an equal amount of time in each country can the application be submitted to the Consulate of the country that will be your first entry point to the Schengen area.

In order for the Swiss representation to have the information it needs; the letter must contain at least the following elements: a. The host's declaration that he is expecting the applicant; b. The full contact details (surname, first name, date of birth, address, telephone number, email address) of the host; c. The period of stay. d. Biometry

Personal appearance of the applicant is mandatory to submit a visa application, if the fingerprints have not been captured during the last 59 months. If the fingerprints have been captured during the last 59 months, they will be copied, and the application can be filed through a representative duly authorized. (Power of Attorney)

In General

- Documents that are not issued in German, French or English must be submitted together with a translation.
- Each visa application is reviewed individually. The Swiss representation reserves the right to request further documentation.
- Submission of an incomplete application may lead to a refusal of your visa application.
- Once the application has been submitted, no detailed updates are provided and you should not contact the representation by phone or email during the processing period.
