	<b>ORIGINAL</b> passport, copy of passport and previous Schengen visas. The passport must be valid at least three months after the intended return and must contain at least two blank pages. Any previous passport must also be included (original only)	
	COPY of the Kyrgyz Residence Permit/Registration (for non-Kyrgyz citizens) <b>NO ORIGINALS</b>	
	1 recent, good quality photo (glued to the application form). The photograph must fulfill Schengen standards, Size 3.5 x 4	
	Confirmed roundtrip flight reservation	
	COPY of Travel Medical Insurance, valid throughout the territory and the duration of the stay in the Schengen area. The minimum coverage of the insurance is of EURO 30'000.00. The insurance must mention SHENGEN on the territorial validity. <b>NO ORIGINALS</b>	
	Confirmed hotel booking containing surname and name of the applicant as well as the duration of stay (exact dates of arrival and departure)	
	<b>ORIGINAL</b> Invitation letter from clinic/hospital IN ENGLISH or an official language of Switzerland containing the following information: <ul style="list-style-type: none"> <li>- Surname and name of the patient</li> <li>- Diagnosis, date and duration of the medical treatment indicating who covers the costs</li> <li>- Detailed indication by the receiving clinic of the maximum costs and maximum duration of the full treatment in case of need.</li> <li>- Confirmation that full payment has been received</li> </ul>	
	Medical reports of the local doctors indicating whether the treatment can be done in Kyrgyzstan (and if not, why) – translated in English by a professional translator.	
	<b>ORIGINAL</b> - Detailed PERSONAL bank statement showing all incoming and outgoing transfers for the last 3 months. A bank confirmation of assets is NOT enough.	
	COPIES of proof of civil status (marriage, divorce, death certificate) All documents must be translated to English <b>NO ORIGINALS</b>	
	COPY of the spouse's passport <b>NO ORIGINALS</b>	
	COPIES of birth certificates for all children. All documents must be translated to English. <b>NO ORIGINALS</b>	
	A list of personal properties (in English only). PROPERTY DOCUMENTS ARE NOT REQUIRED AND WILL NOT BE ACCEPTED BY VFS.	

	<b>Additional documentation for minor children (below the age of 18)</b>	
	COPY of birth certificate of the minor applicant <b>NO ORIGINALS</b>	
	COPY of notarized consent form of the parent staying in Kyrgyzstan, signed by both parents <b>NO ORIGINALS</b>	
	COPY of custody decision if the parent is separated from the other parent of the child <b>NO ORIGINALS</b>	
	COPY of death certificate if one parent has died <b>NO ORIGINALS</b>	
	Passport copies of both parents <b>NO ORIGINALS</b>

- All documents in Russian or Kyrgyz language have to be translated in English, German, French or Italian
- Documents in another foreign language will not be considered, even if translated
- The Embassy of Switzerland reserves the right to request additional documents at any time
- Incomplete and inaccurate visa applications may result in a rejection of the visa
- Issuance of a visa does not guarantee entry to the Schengen area
