DUAL VET PROGRAMME COMPONENTS:



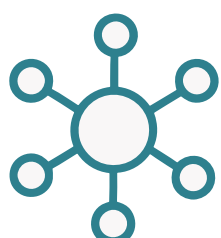
1 This component focuses on the policies as well as the dialogue related to the reform on the dual vocational education and training (DVET) in Romania.

2 It aims at revising and further developing the National Framework of Qualifications (NFQ)/European Framework of Qualifications (EFQ) Level 5, according to labour market needs.

3 This component supports the VET schools/institutions/dual education consortia in piloting/testing the NFQ/EFQ Level 5 through competitive projects (grants) and finance a minimum of 6 training programs for the Level 5.

4 It focuses on the training of DVET teachers/tutors from partner companies as well as on the development of specific training programmes, with the aim to increase the DVET teachers/tutors capacities and further develop their competences.

5 This approach aims at developing a public-private network of DVET facilitators in Romania's 8 regions of Romania, so that the public-private cooperation is improved and the dual education is promoted at local level.
