| <p><b>Procedure</b></p> <p>The process may take several months.</p> <p>The Visa Section of the Regional Consular Center in Bangkok will submit the visa application to the competent cantonal migration office for the place of residence of the parental authority/legal guardian in Switzerland. Once the file is shipped to Switzerland, additional documentation cannot be submitted through our offices but must be submitted directly to the Cantonal Migration Office.</p> <p>Please be aware that only the migration office in Switzerland can provide Information regarding the processing time.</p> <p>In general, the parental authority/legal guardian is informed by the cantonal migration office once the authorization to enter Switzerland has been granted for the child („Ermächtigung zur Visumerteilung“ or “Autorisation habilitant les représentations Suisses à délivrer un visa”).</p> |  |
| <p><b>Collection of Visa</b></p> <p>The Visa D is delivered by the Swiss Regional Consular Center in Bangkok.</p> <p>Please <a href="#">book an appointment in advance</a> and bring the following documents during <a href="#">opening hours</a> (by the applicant or a third person):</p> <ul style="list-style-type: none"> <li>- original passport</li> <li>- copy of the "authorization to Enter Switzerland"</li> </ul> <p>If possible, the visa will be issued immediately.</p>  |  |
