Important notes:

- The original diplomas, degrees, certifications and the criminal record extract (including the documents in Arabic and the translations) need to be legalized by the Libyan Ministry of Foreign Affairs, not the copies.
- Documents in Arabic need to be translated in an official Swiss language (German, French and Italian) or in English. The Arabic document needs to be presented with the application.
- The original diplomas, degrees and certifications will be returned to the applicant on the same day.

The personal presence of the applicant is mandatory.

The Embassy reserves the right to request additional documents.

Fees:

The visa is free of charge. No fees are charge when submitting the application.

Processing time:

Visa applications for the purpose of studies (Stay of more than 90 days) **will be transmitted for decision** to the competent Swiss immigration authority where the applicant intends to reside. The Embassy is only allowed to issue an <u>entry visa</u> upon receipt of a positive decision or authorization.

Please note that the normal processing period is 10-12 weeks at the minimum.

The applicant will have to contact the Embassy per mail beginning from the 10th week after filing the application at tunis.visa@eda.admin.ch, indicating the first name, family name, date of birth, phone number and the application number (mentioned on the receipt) of the applicant.

Appointment and application:
