Applications for the "Visa D Family reunification" are ONLY accepted at the Swiss Consulate General in Istanbul.	
Applicants must submit the application in person.	
No electronically issued (online) documents will be accepted.	
The application for family reunification purposes is sent to the responsible migration authority in Switzerland, which is responsible for approving the application. The Consulate General of Switzerland can only issue the Visa D after receiving the authorization of the migration authorities.	
A waiting period of at least 8-10 weeks must be expected (even longer).

Detailed family register extract (with apostille) Original, current document issued by the Turkish Civil Registry Office (Nüfus Müdürlüğü) All civil status entries and family relationships must be visible	
Translation from the detailed family register extract o Original, translated into a Swiss national language (German, French or Italian) by a sworn translator o Please do not have it certified by a public notary	
If the parents are divorced, divorce certificate with date of legal effect (with apostille) o An original copy certified by the court (Aslı gibi nüshası) o The document must be signed and stamped with the original court stamp o It must be clear which parent has been awarded custody	
If the parents are divorced translation from the divorce certificate with date of legal effect o Original, translated into a Swiss national language (German, French or Italian) by a sworn translator o Please do not have it certified by a public notary	
If one parent is deceased, International Death Certificate Form C (with Apostille) Original, not older than 6 months, issued by the Turkish Civil Registry Office (Nüfus Müdürlüğü)	
Declaration of consent from the parent who will not be travelling together with the child (Muvafakatname) Original, current document issued by a public notary	
Translation of declaration of consent from the parent who will not be travelling together with the child o Original, translated into a Swiss national language (German, French or Italian) by a sworn translator o Please do not have it certified by a public notary
