

## **VISA D – FAMILY REUNIFICATION**

Page 1

**Attention:** Nationals who are resident in Switzerland with a valid residence title and who have married in Turkey must inform themselves beforehand at their competent civil registry office in Switzerland whether **the registration of the marriage** by the Consulate General in Istanbul is necessary (for Swiss nationals this registration is required by law). If necessary, please contact **istanbul@eda.admin.ch**.

## **GENERAL INFORMATIONS FOR FAMILY REUNIFICATION:**

Applications for the "Visa D Family reunification" are ONLY accepted at the Swiss Consulate General in Istanbul.	
Applicants must submit the application in person.	
The Consulate General of Switzerland reserves the right not to accept incomplete dossiers.	
No electronically issued (online) documents will be accepted.	
The application for family reunification purposes is sent to the responsible migration authority in Switzerland, which is responsible for approving the application. The Consulate General of Switzerland can only issue the Visa D after receiving the authorization of the migration authorities.	
A waiting period of at least 8-10 weeks must be expected (even longer).

If a "Visa D - Preparation for Marriage" is applied for, the same documents must be submitted (except International Marriage Certificate Form B).
