

## Required Documents for Schengen Visa C: Transit Visa / Airport Transit (maximum 90 day's)

## Information sheet for people travelling through Switzerland to another, non-Schengen State. The transit passenger is not allowed to leave the transit area in the airport.

The Schengen visa application has to be submitted at VFS Global: <u>https://visa.vfsglobal.com/tur/en/che/</u>

Please submit all documents in following order and do not staple them	
<ul> <li>Visa application:</li> <li>Duly completed (German, French, Italian or English) with a blue or black pen</li> <li>Personally signed in the foreseen box</li> <li>If your fingerprints are already stored in the Schengen System an authorized person in possession of a dated and signed letter can submit your visa application</li> </ul>	
<ul> <li>Valid Passport: <ul> <li>Issued within the last 10 years</li> <li>Minimum 2 empty pages</li> <li>Valid at least 3 month after leaving the Schengen Area</li> <li>Copies of passport (pages 2-3) and previous visas with entry/exit stamps</li> </ul> </li> <li>Non-Turkish nationals: <ul> <li>Proof of residence in Turkey, valid three months beyond the intended date of departure from the territory of the Member States</li> </ul> </li> </ul>	
1 recent biometric passport picture (not older than 6 months)	
<ul> <li>Accident and Health Insurance (Original and copy):</li> <li>Signed and stamped</li> <li>Minimum coverage of EUR 30.000 / USD 50.000 / CHF 50.000</li> <li>Valid for all Schengen countries and the total duration of the intended stay</li> <li>The insurance must cover the costs of any repatriation for medical reasons, emergency medical care and/or emergency hospitalization</li> </ul>	
<ul> <li>Flight reservation (Roundtrip)</li> <li>Flight reservation for the journey to final destination</li> </ul>	
<ul> <li>Travel itinerary</li> <li>Documents or entry into the country of destination</li> </ul>	
<ul> <li>Minors, travelling alone:         <ul> <li>Current notarial declaration of consent of the of legal representative (muvafakatname) original and copy, the original will be given back</li> <li>Legal representative: Divorce decree with child custody or death certificate</li> </ul> </li> <li>Minors, travelling with 1 parent or accompanying person:         <ul> <li>Current notarial declaration of consent of the of legal representative (muvafakatname) original and copy, the</li> </ul> </li> </ul>	
<ul> <li>Content notatial designation of consent of the of logic representative (intervalutation) of ginal and copy, the original will be given back</li> <li>Legal representative: Divorce decree with child custody or death certificate</li> <li>Accompanying person, valid passport and valid Schengen visa</li> </ul>	
Visa fee:	
<ul> <li>Payment: Only in Turkish currency and cash:</li> <li>Adult: 90 €</li> <li>Child, 6 -12 years: 45 €</li> <li>Child, 0 - 6 years: 0 €</li> <li>Visa fee's for spouses of Swiss or EU/ Schengen citizen are free of charge</li> </ul>
