

## Checklist tourist and private household employees' visa

1.	Application form Duly filled in (English, German, French, Italian) and completed, dated and signed by the applicant himself or the legal guardian. If the applicant is a minor under the age of 18, both parents must sign the form and add a copy of their passports. If one of the parents is unable to sign the form, he/she must submit a letter of agreement together with a copy of his/her passport. 2.	All documents must be in English, translated to English, or in an official Swiss language.	
3.	One recent passport photograph ( <u>not older than 6 months</u> ), size must be 3.5 x 4.5 cm with a light background. Photo glued on application form. Head covers are not permitted except for religious reasons. 4.	<ul> <li>Passport <ul> <li>The original passport.</li> <li>The passport must contain the signature of the passport holder.</li> <li>The passport must contain at least two empty pages.</li> <li>The passport issued within the last 10 years.</li> <li>The passport must be valid for at least 3 months beyond the intended departure date from the Schengen States.</li> </ul> </li> </ul>	
5.	Accommodation Proof of accommodation for each night as per the entire intended trip in Schengen (for example confirmed hotel reservation(s), copy of rental contract or proof of residential property).	
6.	Flight ticket Copy of flight reservation (incl. return flight).	
7.	<b>Travel insurance</b> A travel medical insurance covering emergency medical, hospitalization and repatriation (including in case of death). The minimum cover should be of 30.000 EUR. This insurance must be valid for the entire Schengen area and throughout the duration of the stay.	
8.	Financial means Verifiable evidence of sufficient means of subsistence during intended stay: a) Payslips b) a valid international credit card accompanied bank statements c) bank account statements for the last three month; or d) a national form for proof of sponsorship and/or accommodation	
9.	<ul> <li>Company letter of your employer and trade license OR NOC letter spouse/children         <ul> <li>For the company letter: on a proper letterhead with contact details incl. email and phone numbers, duly stamped and with the name and position of the signatory. Please note that also the company's owner requires such letter however, not signed by him/herself. The letter must contain the following information about the visa applicant: the company, position, joining date, salary and the dates of the approved leave. The company has to assure/confirm the continuation of the employment after the desired trip abroad.</li></ul></li></ul>	
10.	<b>Minors</b> Minors travelling without their parents/legal guardian: original authorization signed by their parents/legal guardian in front of a visa officer or duly legalized and copy of passport(s) of parents/legal guardian.	
11.	United Arab Emirates or Bahrain resident permit Has to be valid for another three months (3) after the intended departure from the Schengen States. GCC citizens shall submit a copy of their valid United Arab Emirates/Bahrain resident permit card.	
12.	<ul> <li>Household employees</li> <li>Letter of your employer / sponsor The letter must contain the following information about the visa applicant: the sponsor/household, position, joining date, salary and the dates of the approved leave, eventually with the sponsor's family. The sponsor/household has to assure/confirm the continuation of the employment after the desired trip abroad.</li> </ul>	

**Note for children and spouses of Swiss and EU/EFTA nationals:** Points 5, 6, 7, 8, 9 do not apply. Instead, please include the following documents: Copy of valid Swiss or EU/EFTA passport (of spouse/parent) and proof of family relation (copy of marriage or birth certificate, legalized by the competent UAE / Bahrain authorities).

## Please be aware:

- For all types of Schengen visas, the process time takes in general 15 days
- During the visa processing time, <u>no passport withdrawal is possible</u>
- The Embassy of Switzerland in Abu Dhabi reserves the right to ask for additional supporting documents and/or a personal interview
