The United Nations Educational, Scientific and Cultural Organisation (UNESCO) was founded in 1945. UNESCO's mission is to contribute to the building of a culture of peace, the eradication of poverty, sustainable development and intercultural dialogue through education, the sciences, culture, communication and information with its 195 Member States and ten Associate Members. UNESCO Headquarter is located in Paris, France. The Organisation has some 54 Field Offices worldwide and also includes 11 specialized centres and Institutes disseminated around the world.



The **United Nations High Commissioner's (UNHCR)** original mandate set out in its statute (annexed to UN General Assembly Resolution 428 of 1950) is to ensure on a non-political and humanitarian basis the protection of millions of refugees, asylum seekers, internally displaced people and stateless people, worldwide. It does this by promoting international agreements, helping states establish asylum structures, coordinating the provision of assistance and relief and acting as an international watchdog on refugee issues. UNHCR promotes the human rights of persons of concern to the organisation and works with partners to find durable solutions to their plight.



The **United Nations Children's Fund (UNICEF)** is a leading humanitarian and development agency working globally for the rights of every child. Child rights begin with safe shelter, nutrition, protection from disaster and conflict and traverse the life cycle: pre-natal care for healthy births, clean water and sanitation, health care and education. UNICEF has spent nearly 70 years working to improve the lives of children and their families. UNICEF also lobbies and partners with leaders, thinkers and policy makers to help all children realize their rights – especially the most disadvantaged.



The United Nations Interregional Crime and Justice

Research Institute (UNICRI) assists intergovernmental, governmental and non-governmental organizations in formulating and implementing improved policies in the field of crime prevention and criminal justice. The Institute identifies appropriate strategies and instruments for crime prevention and control so as to contribute to socioeconomic development, increased security and protection of human rights, by designing practical models and systems that support policy formulation, implementation and evaluation.

With more than 1,600 staff, it is the biggest duty stations outside of United Nations headquarters in New York. UNOG manages the United Nations facilities in Geneva and provides conference services for the United Nations meetings held at Geneva.

The UPU sets the rules for international mail exchanges among its 192 member countries, develops technical standards and encourages the adoption of regulations among all postal sector players. The UPU also works to stimulate trade facilitation, social, financial and economic inclusion through the postal network. Member countries rely on the UPU for technical assistance to help them strengthen their postal network, processes and offerings.



The **World Customs Organisation (WCO)** is an independent intergovernmental organisation whose primary mission is to enhance the effectiveness and efficiency of Customs administrations worldwide. As the only intergovernmental organisation specialized in Customs matters, the WCO currently represents 181 Members across the globe at all stages of social and economic development. Being the global centre of Customs expertise and the voice of the international Customs community, the WCO provides an ideal forum for Customs administrations and their stakeholders to hold in-depth discussions, exchange experiences, and share best practices on a range of international Customs and trade issues.





The **World Food Programme (WFP**) is the leading humanitarian organization fighting hunger worldwide and working towards the global goal of ending hunger by 2030. WFP is delivering food assistance in emergencies and working with communities to improve nutrition and build resilience. Twothirds of its work is in conflict-affected countries where people are three times more likely to be undernourished than those living in countries without conflict. It is responsible for providing leadership on global health matters, shaping the health research agenda, setting norms and standards, articulating evidence-based policy options, providing technical support to countries and monitoring and assessing health trends. More than 7000 people from more than 150 countries work for the Organisation in 150 WHO offices all over the world.



The **World Intellectual Property Organization (WIPO)** is the global forum for intellectual property policy, services, information and cooperation. A specialized agency of the United Nations, WIPO assists its 189 member states in developing a balanced international IP legal framework to meet society's evolving needs. It provides business services for obtaining IP rights in multiple countries and resolving disputes. It delivers capacity-building programs to help developing countries benefit from using IP. And it provides free access to unique knowledge banks of IP information



Over the past 60 year, the **World Trade Organisation (WTO)**, which was established in 1995, and its predecessor organisation the GATT have helped to create a strong and prosperous international trading system, thereby contributing to unprecedented global economic growth. The WTO currently has 164 members, of which more than one-fifth are represented by least-developed countries. WTO activities are supported by a Secretariat of some 700 staff, led by the WTO Director-General. The Secretariat is located in Geneva, Switzerland, and the three official languages are English, French and Spanish.
