Tasks

Reporting to the Lead Analyst of a Unified Team in support of the ongoing investigation, the Imagery Analyst is expected to:

- to effectively and correctly apply current imagery analytical tradecraft to develop and produce finished imagery analytical products in support of the current investigation and supporting analytical production plans;
- Provide to the investigators and team leadership with professional advice, knowledge, and insights
 as to the application and capabilities offered through imagery analytical work and capabilities;
- Support the Lead Analyst in the development of staff assigned to their team and in particular their analytical capability;
- Support the Lead Analyst in the development of the team RFIs and analytical production and collection plans.

Expected Professional Qualifications and Skills

- Minimum 7 years of experience in police investigations, with at least 4 years working specifically with children; experience in an international context is an asset;
- Training credentials or other demonstrated expertise related to current bestpractices and scientific knowledge regarding child forensic interviews are highly desirable.
- Have experience in operating in high-risk environments following strong security protocols.
- Ability to adapt standards to the reality of post-conflict environments;
- Ability to work effectively and constructively;
- Ability to work independently and under stressful conditions;
- Ability to keep strict standards of confidentiality and information security;
- Ability to work in a non-discriminatory manner, with respect for diversity;
- Relevant computer skills;
- Professional integrity;
- Good Knowledge of English

Other Requirements

- Good passive knowledge of two Swiss official languages.
- A valid driver's license and experience driving a vehicle with manual transmission is required;
- Physical and mental fitness to work in this context (Assignments are subject to successfully meeting the medical standards);
- Swiss nationality (Dual citizenship with country of assignment not possible).
